Items entered in Departments 16 through 47 are to be delivered to the fairgrounds Monday, August 19 between 10:00 a.m. and 8:00 p.m. **ALSO** - Additional time: any **NON-PERISHABLE ENTRIES** can be delivered to the fairgrounds on Sunday, August 18 between 4:00 p.m. and 8:00 p.m. Please pick up your entry tags outside the Fair Office before proceeding to the Department/Building where the Superintendents will be stationed to accept your entries. All entries must be in place by 8:00 P.M. and remain in place until 8:00 P.M. Sunday. **Unless the entry is made in the classification in which the article is named, no premium will be awarded. Exhibitors must determine for themselves in which classification they will make their entry.** ABSOLUTELY NO CHANGES WILL BE MADE AFTER ENTRIES CLOSE ON AUGUST 6TH.
