COVID-19 Release Agreement and Waiver of Liability

This Agreement is made between Portage County Agricultural Society dba Randolph Fair (“Randolph Fair”) and the undersigned (referred to as Attendee.) Attendee voluntarily wishes to attend and participate in the Portage County Randolph Fair, Junior Fair Show 2020. In consideration of being permitted to attend and participate in the Randolph Fair, the undersigned Attendee agrees as follows:

1. **I understand and accept the risks.** I am personally responsible for my safety and actions while at the Portage County Randolph Fair. I understand that the COVID-19 pandemic has created risks and circumstances that are continuing to evolve and may change over time. Randolph Fair does not claim to have expertise in matters relating to infectious diseases, therefore it is my responsibility to become and stay educated about how to protect myself from becoming infected or spreading transmission of infectious diseases. It is my responsibility to stay current on information, recommendations and orders from the Center for Disease Control (CDC), the Ohio Department of Health (ODH), and other credible sources. Knowing the dangers, hazards, and risks posed by COVID-19 and social gatherings, Attendee agrees to assume all risks and responsibilities surrounding Attendee’s participation in and attendance at the Randolph Fair. Attendee acknowledges that they are at a higher risk of contracting COVID-19 due to being in close proximity with other attendees at the fair.
2. **I will follow all Fair policies and rules.** I will abide by all policies, procedures and instructions of the Randolph Fair, including but not limited to all guidelines, signage, and other instructions.
3. **I will follow other federal, state and local rules.** I will abide by all laws, rules, orders and recommendations of the CDC, ODH, and other applicable governmental agencies regarding COVID-19 and other infectious diseases.
4. **Failure to comply.** I agree that anyone who fails to comply with this Agreement may be excluded from attending or participating in the Randolph Fair.
5. **Cancellation.** I also agree and acknowledge that the Portage County Randolph Fair Board of Directors (“the Board”) may cancel the event in its sole discretion, even while the event is in progress, if the Board believes that one or more participants or guests are violating Randolph Fair rules, or any other laws, rules, orders and recommendations of the CDC, ODH, and other applicable governmental agencies regarding COVID-19 and other infectious diseases. The Board may also cancel the Randolph Fair if one person, tests positive for and/or contracts COVID-19 while attending the Randolph Fair.
6. **Monetary losses.** The Attendee understands and agrees that the Randolph Fair is NOT responsible for monetary losses of Junior Fair Show projects or for monetary losses should the Attendee contract COVID-19 during the Junior Fair Show.
7. **Hold Harmless/Indemnification.** I agree to hold the Portage County Agricultural Society harmless and will indemnify Randolph Fair for any claim whatsoever that occurs to me or

my minor children, including harm, injury, or illness to persons, including death, or harm, loss, or damage to personal property.

8. Term. The term of this Agreement shall continue until the State of Ohio lifts all COVID-19 related mandates, but for the terms set forth in Paragraphs 6 and 7 above which shall be perpetual and shall survive the term of this Agreement. If I am signing for a minor, I understand this Agreement includes, but is not limited to, an action brought by the minor upon reaching the age of majority. I warrant that I am authorized to execute this document on behalf of the named minor.

THIS IS A RELEASE OF LEGAL RIGHTS. READ BEFORE SIGNING. IF ATTENDEE IS A MINOR (UNDER 18 YEARS OF AGE), A PARENT OR LEGAL GUARDIAN MUST SIGN BELOW.

I have carefully read the above document and am signing it freely. I understand that by signing this document, I am assuming the risks of attending the Randolph Fair and releasing the Portage County Agricultural Society of all liability, as outlined above.
