

- All Junior Fair Market Exhibitors are required to also complete a **Jr. Fair Market Livestock Entry form and W-9**. They must be turned in to the Fair Office. (Specific species may require addition entry forms in order to be eligible to show at the Portage County Randolph Fair.)
- Jr. Fair Market Livestock Entry deadline date is the same as the Senior Fair Board deadline for Open Class entries. Deadline is Tuesday, August 10th at 8:00 p.m. No late entries will be accepted and all information must be correct and consistent with all pre-fair weigh-in and tag in and specie specific entries.
- All Junior Fair Market Exhibitors must follow the Sale Committee rules including the 2-1-1 rule.
- Any market animal brought to the fair that does not match the entry form information and/or pre-fair weigh in/tag in information will be disqualified and must be removed from the fairgrounds as directed by Fair Superintendents.
- Jr. Fair Exhibitors are responsible for the care and feeding of their livestock until it is released from the fairgrounds.
- All livestock exhibited must conform to respective specie committee's animal identification requirements, rules & regulations.
- All Agricultural Education, FFA, County Schools, Career Clubs, Youth Organizations please refer to page 29, Departments 7 thru 9 for entry/display information.
- ALL Judge's rulings are final.

HEALTH & SAFETY REGULATION

- A **correctly and fully completed** and signed Drug Use Notification Form (DUNF) for each market animal must be in the hands of the Fair Records Official before the initiation of the show, or the exhibitor will not show that animal. Therefore, all market livestock exhibitors must complete a **DUNF and turn it in at weigh in or check in. Species must turn in completed & checked forms by 9 p.m., Monday before fair.** Please see Ohio's Livestock Tampering Exhibiting Rules Prohibited practices 901-19-04 and 901-19-06 in this fair book.
- If at any time after the DUNF is filed the information on the form regarding drug use changes or if a drug is subsequently administered with Fair Veterinarian direction, an updated DUNF shall promptly be filed with the superintendent and forwarded to the Records Official of the Fair Board.
- All animals must meet the Health Regulations and follow the Livestock Tampering Exhibition Rules of the State of Ohio Department of Agriculture. It is the exhibitor's responsibility to read and follow the regulations. A printed copy of these rules are in the Portage County Randolph Fair Premium book.
- Any animal deemed unsafe, uncontrollable or unhealthy by the Fair Veterinarian along with the Department Fair Board Superintendent can be sent back to the barn and/or home and can not return this year's fair.
- Fair Board, Committees, advisors, Fair Superintendents, and Ohio University Extension personnel are not responsible for theft, injury, or loss of personal property belonging to exhibitors or spectators. Exhibitors participate in Fair activities at their own risk.
- All Horse Exhibitors must meet Horse Safety & Ethics & Horse Helmet Rules. Please refer to Portage County Horse Committee rules.
- Portage County Randolph Fair shall contract the services of the Fair Veterinarian during the week of the fair. However, if an exhibitor desires to contact a different veterinarian, he/she may do so at their own expense. The fair vet. reserves the right to charge an exhibitor for any medical or surgical supplies dispensed.

ADMISSION

- Wristbands will be distributed to Jr. Fair members in good standing by their advisors. Advisors and committee members in good standing will report to the Fair Office during assigned times to secure the Jr. Fair Participation Packets. Assigned times will be in the Fair Edition of the Ohio State University Portage County Newsletter or by calling the Fair Office in July. Assigned times are usually within 10 days prior to the start of the fair. Pick-up Dates - Aug. 22nd - 12-2 p.m. & Aug. 23rd - 10 a.m.-12 p.m.

JUNIOR EXHIBITORS SHOW OPEN CLASS

- Jr. Fair Exhibitors are encouraged to show in the Senior Fair. Rules and Regulations to do so are in the Senior Fair Department sections of this fair book. Entry forms are required and an entry fee in certain departments is required. Please see the specific sections of this book for the departments interested in entering. OVERNIGHT PASSES

- Those Jr. Fair Livestock Exhibitors who wish to stay overnight on the grounds must be registered. There must be a responsible adult supervisor at the barns at all time. The Fair Board nor Ohio State University Extension assumes any responsibility for persons staying on the grounds. Contact OSU Extension office for details.
